

- 1. Scott Walstra, Board President, read from Philippians 2: 1-11 and opened with prayer.
- 2. Thank you to the board members who are retiring; Tony T. Bos, Rob Buiter, Mark Dyke, Dave Heerema, Mark Schurman, and Scott Walstra. Also thank you to John Thomas and Irv Dorn who will be retiring from the Foundation Board this year.
- 3. Introduction of candidates for:
  - a. DeMotte Christian Schools, Inc. Board of Directors: (Voting for 3) Eric Bult, Nathan DeBoer, Todd DeVries, Dale Nieuwbeerta, Dan Perkins, and Jason Putman
  - b. DeMotte Christian Schools, Inc. Foundation Board: Rudy Tolkamp and Gina Van Baren

<u>Finance Committees Comments for 2016-2017 Budget</u>

#### Comments Related to the 2016-2017 DeMotte Christian Schools, Inc. Advisory Budget

- 1. Tuition Fee Income This advisory budget is based on a projected enrollment of 423 students (315 at DeMotte Christian and 108 at Covenant which is the current enrollment). The 2015-2016 Advisory Budget was calculated using a projected enrollment of 401 students (295 at DeMotte Christian and 106 at Covenant). The majority of the projected growth is the result of adding a 3/4 year old preschool class at DeMotte Christian. With a 3% increase on the base tuition, the one child tuition for 2016-2017 will be \$6129 at DeMotte Christian and \$7,718 at Covenant. There will also be a change in the family discount rate calculation. For additional children, the discount rate will remain at 5% in the high school, change from 8% to 7% for full-time students in grades K-8, change from 4% to 3.5% for part-time students in Kindergarten, and change from 4% to 2% for full-time students in Preschool.
- 2. Carrying on the Promise General Fund Portion Since the merger in July of 2014, this drive is not meeting the goal of \$190,000. The decrease of \$15,000 resulted in approximately a 0.5% increase in the base one child tuition rate.
- 3. Carrying on the Promise Tuition Assistance Portion This portion has been eliminated for the 2016-17 budget. The main factors are a healthy balance in the account, generous individual and church contributions, and less demand with the advent of the Indiana Choice Scholarship (Voucher) program.
- 4. Foundation Fund Disbursement This reflects increased funding due to the performance of the Foundation Fund.
- 5. Salary Expenses:
  - a. Office / Support This reflects the high school guidance counselor position becoming a full-time position.
  - b. Salary Expenses include increases of 1.25% on the teacher salary scale base pay, 0.25% on teacher salary scale increments, and 1.50% increase on non-teacher pay.
- 6. Medical & Life Insurance Expense This reflects a change in carrier that began in the 2015-16 fiscal year.
- 7. Utilities Expense This more closely reflects actual expenses.
- 8. Building Repair & Maintenance This more closely reflects actual incurred and anticipated expenses.
- 9. Bus Operation Expense This reflects lower fuel costs.
- 10. Capital Improvement Loan Payback This new line item reflects the payback of a loan that will be taken out to pay for improvement in the parking lot at DeMotte Christian and the paying of the side drives and back parking lot at Covenant.
- 11. Bus Replacement With the purchase of new busses there is a need to resume setting aside funds for additional purchases in the upcoming years. This past year an additional activity bus was purchased and there is the need to replace two of the aging yellow school busses.
- 12. Copier Maintenance & Supplies This reflects new contracts for copiers and printers at both schools.
- 13. Public Relations Expenses This reflects the addition of funds in this account to make it possible to contract for some services with certain specific skill sets.

#### To figure additional children:

- If the 2<sup>nd</sup> child is in the high school, there is a 5% discount on the total family tuition bill.
   If the 2<sup>nd</sup> child is a full time K-8 student, there is a 7% discount on the total family tuition bill.
- If the second child is a part-time K student, there is a 3.5% discount on the total family tuition bill.
- ➤ If the second child is a PS student, there is a 2% discount on the total family tuition bill.

#### Examples are:

Grades 9, 6, and 3

Step 1: 77.718 + 6.129 + 6.129 = 19.976

Step 2: 0% discount + 7% discount = 14% discount for the family

Step 3:  $19,976 \times 86\% (100-14) = 17,179$ 

Grades 6, 3, and PS (4/5)

Step 1: \$6,129 + \$6,129 + \$1,226 = \$13,484

Step 2: 0% discount + 7% discount + 2% discount = 9% discount for the family

Step 3:  $13,484 \times 91\% (100-9) = 12,270$

#### DEMOTTE CHRISTIAN SCHOOLS, INC. SOCIETY MEMBERSHIP AFFIRMATION

Re: Annual Society Meeting, April 5, 2016

I am in agreement with the following Statement of Purpose and Faith and the Educational Philosophy as stated in the Bylaws of DeMotte Christian Schools, Inc.

#### Article II. STATEMENT OF PURPOSE AND FAITH

Section 2.01. The Corporation shall have as its primary purpose the establishment, operation, and promotion of a school to educate students in such a way that each student will become a useful and creative citizen of Christ's Kingdom and of the student's community, state and nation, with the desire and ability to apply the student's Christian commitment and principles to all of life's situations.
